3. Set Up 2 Factor Authentication

Two-Factor Authentication

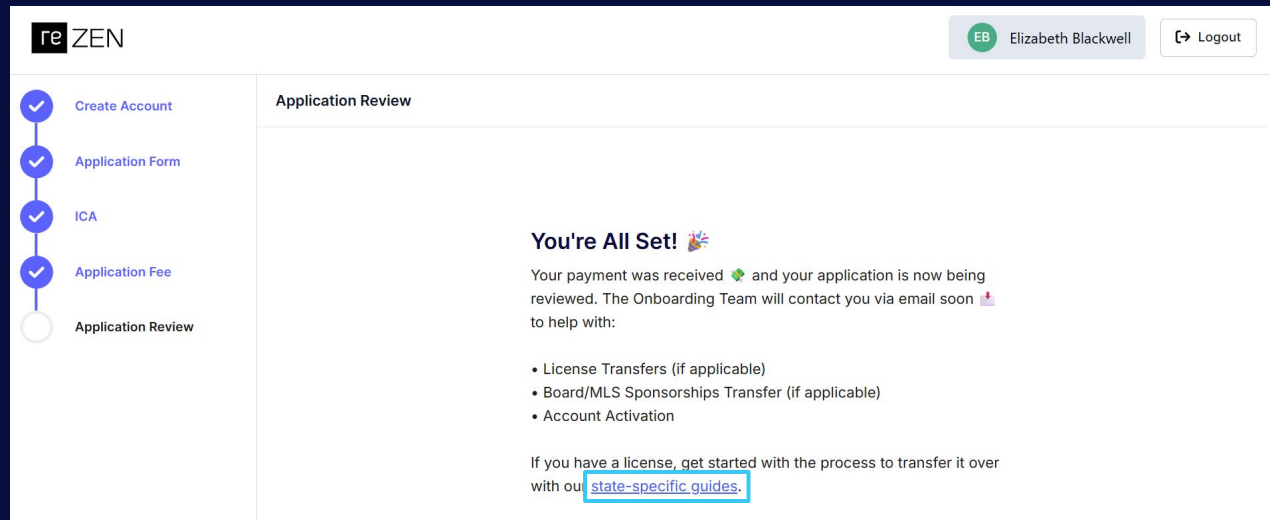

- Go to www.dre.ca.gov and login to the E-Licensing section using your existing login and password. If you have not set up a login you can register for a new login.
- Once inside the E-licensing section choose "Change Employer" and then enter Real Broker's license #: 02022092.
- You will be asked if the Broker is available to confirm the transfer, choose "NO" and enter our California Broker's E-mail address: cabroker@therealbrokerage.com. Our broker will receive the message and confirm the transfer.
